3. **President's Opening Address**

Kathy welcomed all representatives of the Member Clubs to the Spring AGM and read her opening address, which is available on the CLGA website.

4. Director's Reports

The following Directors provided the following reports:

- Davona Walton provided the 5-year planning report.
- Wendy Ellacott spoke about Communications and Marketing and provided the Junior Development report.
- Erin Wagner provided the Treasurer's report.
 - October 31, 2024 Audited Financial Statements approved by the Board April 10, 2025
- Pam Scott gave the report for the upcoming events this year on behalf of Tournament Director Carey-Ann Ramsay.
- Cindy Beaudet gave her report as Past President.
- No questions raised on the reports by those in attendance. All reports are available on the CLGA website.

5. **Discussion further to reports**

- Cindy requested a volunteer for tournament chair for Senior Cities at Valley Ridge. The tournament chair would work closely with the Head Pro.
- A question from the floor was addressed regarding "growth" of golf noting that the number
 of course members are down this year by one (Lynx Ridge). It was explained that after
 several years communicating with representatives of Lynx Ridge, they determined they
 could not support the CLGA's hosting requirements as a Member Club and withdrew their
 membership.
- Wendy Ellacott did mention that we have full participation in our events and ladies golf is healthy in the CLGA now.

6. New Business

CLGA Bylaws: with support of the Board, the Bylaws were updated to incorporate 2023 updates to the Alberta Societies Act as well as recent special resolutions passed by the Member Clubs over the last three years. The wording in many cases has been clarified to enhance understanding but follows the original intent of the 2019 Bylaws. These Bylaws were sent out to Member Clubs two weeks prior to the AGM for review with the intention to vote on them at this AGM.

Maple Ridge questioned which events need a host club on an annual basis. Discussion clarified that the list of events the CLGA supports was removed from the Bylaws as we decided that showing the yearly events on the CLGA website would facilitate the flow of information much more readily than constantly updating Bylaws. The current hosting structure in place is as follows:

- Member Clubs host 1 major event every 10 years in a rotation, which currently are:
 - ➤ Major-Calgary Ladies Amateur closed, 3 days 96 players
 - ➤ Major-Calgary City Seniors Amateur closed, 2 days 96 players
 - ➤ Calgary City Girls Junior open, 2-days
- ❖ All Member Clubs are required to host other events as their turn comes up in rotation or which are yearly events currently as indicated below:
 - ➤ Harriet Watson Tournament of Champions 1 day in September
 - City Medalist Series 5 tee times once every 3-5 years
 - ➤ Rileys Best Ball Ladies Classic Match play 2-lady team (yearly home & away games only if you have a team in Rileys)
 - > C.H.A.M.P.S. (Calgary Hospitality and Match Play Section), 5-7 home games per summer (yearly only if you are a member of C.H.A.M.P.S.)
 - > C.H.A.M.P.S. Wind-Up 1 day in September (only if you are a member of C.H.A.M.P.S.)

Unless the Member Club has a team in Rileys or is a member in C.H.A.M.P.S., which would be annual commitments, any other hosting event would be facilitated on a rotation basis based on the Member Club's ability to host certain events. This led to a long discussion as city club members are concerned they will not be able to play in CLGA events because the city might not agree to host any CLGA events. The city club members felt they really have no influence over the city's decision regarding hosting events to maintain membership in the CLGA and that members of the city run courses are in a unique situation relative to members of private golf courses. It was suggested that if hosting an event is not feasible for the city courses then the CLGA Board will try to not only understand the restrictions imposed on the city club members but be creative in finding a successful go-forward to keep the city club members part of the CLGA. Negotiations are still ongoing between the City and board members of the CLGA.

Another question was raised around whether member club reps are going to be asked to offer the opinion of their members on the issue of allowing City members to participate in CLGA even if the City will not meet hosting requirements, as an example, or any other issue that is under review, then they would need the information on the topics to be discussed prior to the upcoming general meeting so that they can discuss the issue with their members ahead of the meeting and be comfortable speaking on behalf of their club. Board members present felt that was a good point in general and we have made every effort to provide information in a timely fashion when a member vote is required; however, with respect to membership in the CLGA, it is ultimately up to the Board to decide whether a club meets the requirements to remain a member of the CLGA. As mentioned, we need to consider the city club members specific situation and work with them to determine what works best for both.

It was reiterated that these hosting concerns should not negate the approval of the revised Bylaws as the hosting requirements have been in place for many years and were not changed with the current revisions. This is a separate discussion on what the CLGA will support with respect to the city club members. The Board will continue negotiations and bring back further developments of the city situation to the Fall AGM. The following motions were made:

Motion to accept the 2025 Bylaws as they stand: Pat Peters (Priddis) Seconded: Cindy Beaudet (Canyon Meadows) Motion Passed (75%).

Motion that the Board will approach the City and their club reps sometime soon to discuss what options might support city club membership in the CLGA and update the members at the Fall AGM: Erin Wagner (Bearspaw)

Seconded: Jan Van Troyen (Mickelson)

Motion Passed.

7. New Director Positions for Fall 2025

- The VP comes from Woodside as host of the Calgary Amateur (per a Special Resolution passed by Member Clubs last year and now recognized in our 2025 Bylaws).
- We are also looking for a new secretary as Pat Peters' term is up this year.
- Please let Kathy or a member of the Board know of anyone who might be interested.

Motion to adjourn the Spring AGM: Anna Alderson (Pinebrook) Seconded: Diane White (Springbank) Motion Passed.

2025 PRESIDENT'S ADDRESS

May 15, 2025

My name is Kathy Trofin, and I'm the 2025 President of the Calgary Ladies Golf Association's (CLGA) Board of Directors. It has been quite an education and my great honor as president to work closely with the ladies of the Board sitting in front of you this evening. Each of them brings their individual knowledge and strengths to create a great team dynamic that works together to get things done. I truly rely on each lady's expertise in her role, not only to ensure the CLGA's events are run to the best of our ability, but to support each other in developing new opportunities to offer our membership and to promote CLGA's mission to foster participation and excellence in ladies golf while spreading passion for the game.

Reviewing last Fall's AGM Minutes, I saw that the round table feedback indicated some discontent with opportunities for mid-handicappers to enjoy potential CLGA events, other than CHAMPS of course. This would be a two-day event for ladies aged 19 or older that possess a handicap between 12.0 and 40. We would plan to have this as an open event for Alberta residents. So stay tuned on that front.

We have also worked on opportunities for our juniors and have an exciting program this year partnering with Alberta Golf. Wendy Ellacott will tell you more about this in her report.

Anybody that checks out our website or sees our letterhead may have clued in to the fact that the CLGA will be celebrating a centennial anniversary in four years' time. Cindy will be bringing you up to speed on some of our initial plans for this exciting event as well as other initiatives in the works. Speaking about the website, you'll notice several changes this year which I hope will provide an even better experience for our membership to find out what's what in the CLGA. So please take a look, and feedback is always welcome.

Calgary Ladies Golf Association Marketing and Communications Director Report May 15, 2025

It's been an ongoing pleasure to provide marketing and communications assistance to the CLGA board. Over the years, the focus is always to improve top of mind awareness and provide information about the organization to the 34 clubs representing more than 5000 women and junior girl members and to the head pros and assistants.

The CLGA depends on word-of mouth among its members and club representatives to spread awareness about the tournaments and events that members can participate in. We really appreciate the assistance that club representatives give us in updating contact information throughout the year. It helps us to ensure that we send important information to the right people at the right time. Thank you for your help.

Details on our offerings can be found on the CLGA website, through e-blasts, social media and on posters. These are the main messaging vehicles. In 2025, the CLGA expects oversubscription to their amateur and senior amateur tournaments and is always oversubscribed for the Rileys Best Ball Ladies Classic. The same holds true for the Medalist Series - there are not enough spots to meet demand.

CHAMPS club participation continues to rebound after the sharp decline after Covid with 18 clubs participating in the city match play hospitality league this year.

The CLGA is proud to announce a new twist in the presentation of the 2025 Calgary Junior Girls' Closed Championship, which will be held June 28th and 29th at the Valley Ridge Golf Club. This year, the event will be held in conjunction with the Calgary Golf Association (CGA) and will be a combined junior girls' and junior boys' tournament. The event is associated with Alberta Golf's McLellan Ross Alberta Junior Tour. It is a 2-day gross total stroke play tournament for competitors ages 9-18, and registrations are open to Alberta residents who carry a Golf Canada handicap factor. All competitors are eligible to win the overall championship, and/or prizes within their flight categories. At a cost of \$99 for two days, we hope to attract at least 30 girls from Calgary and area and contribute to growing the game.

As we look to 2025 and beyond, the CLGA is looking to expand participation even further through the revival of a tournament that specifically targets mid to higher handicapped players. We hope to do this with the help of local partners. More on this by the Fall AGM.

Calgary Ladies Golf Association Tournament Director's Report *May 15, 2025*

I am pleased to provide an update as we prepare for the 2025 tournament season.

Our first event of the year, the Calgary Ladies Closed Amateur, will take place June 23–25 at the Calgary Golf & Country Club. Registration for this event closes on June 9th, and I am pleased to report that we have already secured 68 registrants.

Following that, the Calgary Senior Ladies Closed Amateur is scheduled for August 5–6 at Valley Ridge, with registration open until July 22. Currently, we have 34 players registered for this event. Both events have been oversubscribed in the past and we expect the same this year.

Preparations for both tournaments are progressing smoothly. We are still working to identify a Tournament Chair for the Senior Amateur, but in the meantime, we are working with head pro Chris Paskin. We are finalizing event logistics with Calgary Golf & Country Club and working to ensure a positive experience for all participants. In particular, pace of play will be an area of focus at both events, and we are developing strategies to encourage steady play and minimize slow rounds.

Finally, in response to member feedback, we are actively exploring the reinstatement of the Marg Ward Open, an event previously run by Alberta Golf. Many members have expressed interest in additional competitive opportunities for higher handicap players, and we believe bringing back this event could provide a more inclusive option within our tournament offerings.

I would like to thank our volunteers and committee members for their ongoing efforts as we gear up for what promises to be an exciting and competitive season.

Treasurer's Report – Spring AGM From: Erin Wagner, Treasurer, CLGA May 15, 2025

2024 (October 31) Year-End Financial Report

2024 was another successful year for the CLGA and ladies' golf in Calgary and area.

The CLGA successfully operated the Calgary Ladies' Amateur at Priddis, the Calgary Senior Ladies' Amateur at the Glencoe, the 40th Anniversary of the Riley's Ladies' Best Ball, the CHAMPS and Medalist series and the Tournament of Champions at Canyon Meadows, which unfortunately was rained out, but not without a celebratory lunch for the 2024 club champions.

Each of these tournaments and events were operated at cost recovery, which is the mandate of the CLGA. We finished the year with surplus funds of approximately \$6,000 on total revenues of \$51,000. Revenue sources were tournament entry fees and member club association fees. Expenses totaled \$45,000 for tournament and event hosting, as well as various administrative expenses for marketing, technology, trophies and rules officials. The surplus funds form part of the CLGA's total cash reserves, which total \$32,000 at October 31, 2024.

2025 Budget

For the 2025 season, the CLGA is excited to continue to host its hallmark events and is proud to announce a new Calgary City Junior Girls Championship, in association with the Calgary Golf Association and the McLellan Ross Alberta Junior Tour. We are budgeting revenues consistent with 2024, with member club association fees of approximately \$13,000, in addition to tournament entry fees and the tournament of champions fee revenues. We have seen some increases in costs associated with prizing, tournament scoring and technology fees, so in total, we expect expenses to be equivalent to revenues for the 2025 season.

In closing, thank you to all the CLGA member clubs and lady members for your commitment and passion for golf. In Calgary and Area, the game of golf, in particular, female golf, is extremely strong, thanks to the strength of the CLGA member clubs, their leadership and their lady playing members. We are excited for another exciting year of camaraderie, new friends, and spreading the passion for the great game of golf. Thank you for your continued partnership with the CLGA.

PAST PRESIDENT'S REPORT

May 15, 2025

For those who do not know me, my name is Cindy Beaudet, and I am the Past President of the CLGA. I have recently retired in December 2024 and still love to work with the CLGA. We have a great organization with some changes coming to the CLGA. My passion for golf and our organization is still very high.

Thank you for coming out to the kick-off of the 2025 golf season and annual general meeting. As Kathy mentioned, we are looking at bringing back the Marg Ward Mid Handicap Tournament as well as getting a casino licence. This casino licence would help us facilitate our tournaments and support the junior girls and the mid-handicap event.

This is all a work in progress as we are dealing with the government, and they don't exactly move very quickly.

For those of you who do not know, the 100th Anniversary of the City Amateur is June 2029. We are planning a big celebration for this fantastic event with current and past champions on the invite. However, we will need some volunteers. Do you have experience with archives or securing sponsorships for the event? We will be sending out some job descriptions for roles that we will need to fill. I do hope we get some great participation. We have lots of time to make it all happen, but I'm sure you know time goes by very quickly, so getting on top of things is very important.

Here is an example: Miss Patti Arnold, Calgary Golf and Country Club, 1945-1947. We have so many ladies and their families we'd like to identify to celebrate 100 years.

So, for the 100th anniversary, we will be identifying all the former winners and hopefully inviting them or their families to the championship evening. However, we still need to identify many of them. Why, because names on the Trophy are in their husbands' first names.

We have a club that has agreed to host, and we will announce that once we have confirmation.

Ladies, it's time to assist with the heavy lifting of the CLGA. Golf is changing, as you all know; **tee times are not plentiful**, and clubs are hesitant to offer tee times without generating revenue.
